**TERMS OF CONSIGNMENT**

Subject to the terms and conditions of this Consignment Agreement (the "Agreement"), Rushern Baker IV ("Artist"), hereby consigns to Zidoun-Bossuyt Gallery (« Gallery ») the artworks listed previously (the "Artworks") from November 26, 2019 to June 30, 2020 (the "Consignment Period"). The purpose of the Agreement is to enable Gallery to endeavor to sell the Artworks for Artist's account as well as to show the Artworks at UNTITLED, Art Miami Beach, Gallery's exhibition space and Art Brussels. Gallery will not re-consign the Artworks without Artist's prior written consent. Upon termination or expiration of this Agreement, the Gallery may extend the consignment with Artist for unsold works, or return the Artworks to Artist. This Agreement may be extended by prior written mutual consent of Artist and Gallery.

Gallery may discount the Retail Price by up to 10%. Gallery shall not discount the Artwork in excess of 10% without the prior written consent of the Artist.

In the event an Artwork is sold during the Consignment Period, Gallery and Artist shall be entitled to an amount equal to 50% of the "Net Retail Price" of such sale(s). The Net Retail Price for each Artwork shall be an amount equal to the Gross Retail Price, less any discount permitted pursuant to the terms hereof.

Upon receipt of the Net Retail Price, Gallery will hold Artist's share in trust for Artist. Gallery will not extend any credit to a purchaser without Artist's prior written consent. After payment of the foregoing amount respecting a sale to Artist (by wire transfer to an account designated by Artist) out of immediately available funds, within 30 days of any sale, Gallery shall be entitled to the balance of the sale proceeds remaining (respecting such sale).


Gallery is responsible for all transport costs and for nail to nail insurance of the consigned works against loss, theft or damage at full artist's value. Gallery shall pay any such insurance proceeds to Artist upon receipt thereof. Gallery agrees to use all due care in handling the Artworks.

Gallery will provide the Artist with copyright-free high quality installation views of the Artworks to be exhibited in Gallery's exhibition space (group exhibition from January 30 to March 7, 2020). The Artist is responsible for having all Artworks photographed in studio prior to shipment and will provides Gallery with copyright-free high quality individual images of the consigned Artworks.

This Agreement shall be governed by the laws of the Grand Duchy of Luxembourg, without giving effect to any choice of law or conflict of law rules or provisions. In the event of a dispute arising under or related to this Agreement, the parties hereto submit to the sole and exclusive jurisdiction and venue of the courts of the Grand Duchy of Luxembourg. This Agreement cannot be changed, modified or amended except by express written agreement by the parties.
